8 weeks of round games with 2 week final series. Double Header/Double Points were suggested to help with a later start date and early finish due to school holidays

Decision made on Grades: Drop all A grade divisions for 2020 season only B Grade – both men and women to be played on Saturday and re-named Opens C Grade – women Wednesday and men Friday – no change

Juniors Saturday morning – no change

2019 format to be used for the junior teams when it comes to coaching and teams

14 players per team as per COVID-19 at this time.

When off the field the subs must be in the dugout and 1.5m apart as per COVID-19 rules. Coach to remain outside dugout. Teams at  $\frac{1}{4}$  and  $\frac{1}{2}$  time are to use space on the pitch, not congregate in the dugout.

If there were enough people to make a Barbarian team this could also be worked out.

Training will be decided once the third release of the new COVID-19 rules. NSW Hockey have provided a 1 / 4 field layout which we will adhere to.

Grading for B Grade one GK + 6. GK can also play C-Grade as a field player

If there are two teams in the same grade, no player can cross play.

No new registrations to be submitted after the commencement of the last 4 rounds of competition. Any exemption must be submitted to CMC in writing endorsed by Club President for approval/denial.

Gauge interest in a Super 9 team where additional fees would be paid if they played.

Once all clubs have their memberships finalised we will look at the option of extra rounds/double headers ensuring we provide the teams with enough notice, especially if the rounds will be held on a Sunday.

Association based super 9s (not club based)

Proposal to change the current grading policy to remove the "3 in the last 5" rule for finals qualification.

Acknowledgement that A grade and duel registered (Taree) players will be playing in the Bs/Open grade as it is our highest grade.

Rounds will be held over a 9 week period, and including a 2 week final series.

Minutes from previous meeting: Minutes updated and accepted.

Business arising from previous meeting:

Every team will play for the entire season, with the last match to be 1v2, 3v4 etc, 8 weeks of rounds (team on top of ladder will be Minor Premiers). Week 9 1v2 winner will be Major Premiers.

Juniors Saturday morning no change, incl Under 16s on Thursday night.

GK from B Grade can play on the field in C Grade.

Changed new registrations to "No new registrations will be accepted after Midnight on 18 August 2020".

General Business:

1. Time to increase player numbers to 16 per card per game, from 1/7/2020 this will be okay.

2. Number of players per team - this will be set at 20 registered players per team as per current Policy.

3. Junior Approvals – as per current Policy, however the CMC has a request to update under "Requirements" dot point 2 under 2<sup>nd</sup> dot point "Acknowledgement from the player's club, stating that the player is capable, has the skill set, and has been adequately coached to play in the senior's Competition" to "Acknowledgement from the player's club Executive, stating that the player is capable, has the skill set, and has been has been adequately coached to play in the senior's Competition" to "Acknowledgement from the player's club Executive, stating that the player is capable, has the skill set, and has been adequately coached to play in the senior's Competition"

4. Finals format – as per above and this will be the same for all competitive age group juniors.

5. Season length – discussion had in relation to extending the Competition season through to October. Motion Season to remain as per the Competition Management Meeting minutes and strong recommendation for an Association organised Competition in Term 4, moved KC sec HT. In favour 7 against 1.

6. Player qualification and registrations – as per current Policy. CMC have requested Clubs gauge interest for a Super 9 Club based/gender based competition to be played mid-week along similar guidelines to season 2019.

7. Association looking at Competition in Term 4 – as per number 5.

8. U18 Summer Comp – CMC would like to see this as part of the Term 4 Association Competition. This will gauge interest for the 2021 season for possible inclusion.

9. A grade super 9's format (gender, mixed, approvals, time slot, and game time (3X15 minutes etc etc) – to be carried over until we know interest and numbers.

10. Team nominations due prior to Midnight 7/7/2020.

11. Junior team costs (quarter & half) for U11 & U9s – CMC recommend that U11  $\frac{1}{2}$  field team fee be set at \$450 plus GST and U9  $\frac{1}{4}$  field team fee to set at \$350 plus GST.

12. Plan B if we get delayed due to any outbreaks? – We will worry about this when we need too.

13. Umpires – discussion re umpires, as the Assoc is not paying the umpire fee, there is still the requirement that Clubs provide Umpires for the respective games and penalties will still be applied as per the current Policy. Association Super 9 comp, Association would supply umpires as per 2019.

## General Business:

1. Reply from PMHHA Executive: PMHHA advised in relation to 18/6/2020 Minutes General Business Point 1 "The 1 person per 4m2 will still be in force after 1/7/2020. Given dugouts are approx. 3m x 5m would indicate 4 maybe 5 persons only to fit in the dugout. PMHHA will have Graeme Ferguson to liaise with the CMC re this matter. CMC still feel that 16 players should be okay even if 1 or 2 players are outside the gate if and when teams actually have 16 players. General Business Point 3 Junior Approvals in short the waiver is to be signed by the President or Vice President of the Club, Simon Thresher will ensure Clubs are aware of this. All other recommendations put forward have been accepted. PMHHA would like to propose that rather than rewriting all Policies given the unforseen season we are having that the recommendation be made into a Season 2020 policies addendum. All member of CMC agree with having the addendum for this year.

2. Minkey hockey & Hin2H program – currently both programs are run separately, Ali's idea that maybe they could be run together with the approval from Hockey NSW. Hin2H is a Hockey Australia initiative aimed at juniors that are new to hockey and it costs \$95.00 and they receive skills based training on Monday with it being run by Leigh McIntosh and Terry Rhook, discussion had re whether the Hin2H kids should play in the Minkey/Junior Competition. It was decided that we would leave it to LM to sort out if they play in the Minkey/Junior Competition. LH to email LM to check if happy to run Minkey and incl the Hin2H players.

3. Team Nominations: As following Open Men (5 teams) Camden Haven Port City Wauchope Thunder x 2 Open Women (6 teams) Allstars Camden Haven Port City Wauchope Thunder x 2 C Grade Men (5 teams) Camden Haven Port City Wauchope Thunder x 2

C Grade Women (4 teams) Camden Haven Port City Thunder x 2 Under 16s (5 teams) Camden Haven Port City Wauchope Thunder x 2 Under 13s, Under 11s and Under 9s (4 teams each age) Camden Haven Port City Thunder x 2

Wauchope have expressed concerns that are short of players for their Open Women's and C Grade men's teams, and if any clubs have an excess of players please send them their way. Their U16s are short also with 7 confirmed and 3 to confirm, expressed interest in possible Super 9s competition for under 16s, or need help from other clubs. Requested an exemption for Corban Fraser to play under 16s (aged out this year). Wauchope also have a number of Under 9s and Under 11s however not enough to field a team.

Port City also expressed concerns with their juniors they will have teams with younger players playing up an age group and gender issues (essentially 2 boys' teams). Under 16s expressed an interest in Super 9s competition and an exemption for Ruby Campfield. Under 13s all boys and 8 actual players. Under 9s only 1 female and a number from Under 7s.

CMC approved the exemptions for both Corban Fraser and Ruby Campfield.

Discussed Under16s competition format for 2020 and it was decided that we would stick to the regular 11 a side.

KC will set up a zoom meeting for all junior clubs ie Port City, Wauchope, Camden Haven and Thunder to discuss junior numbers and player availability. All Club participants to ensure they know actual player numbers, this meeting will be next Thursday 16 July.

LH to email Exec to check if kits will be made available this year for new players and if McDonalds transfer needs to be on the Juniors Shirts for 2020, are they still sponsoring juniors in 2020?

4. CMC Primary Functions: LH to check with Exec re: whether there are any match cards or do we need to get some printed. KC will pick up cards, scan and email to LH. LH will monitor cross play, playing restrictions, game limits etc. TH will try to formulate a draw, advised her to get in contact Robyn Charlesworth for assistance.

5. CMC Secondary Functions: TO club to be Duty Club and assist with opening/closing etc. LH to email GF to find out if Spectators come to watch matches who is responsible for obtaining names and phone numbers.

General Business:

1. 2020 Umpire Update – Matt gave us an update in relation to umpiring. There have been no issues to date. Matt has created a under review for grading listing for umpires who will become capable with coaching and development. There are currently 2 umpires identified Hayden Alexander and Bayden Smith who are undertaking coaching with the Umpire Coordinator with the view for them to be able to umpire Open Men's division. Matt advised Haydn Alexander & Bayden Smith can umpire opens men's while coaching continues. TPT wish to put forward 2 further umpires for the C Grade Women's competition. With the double headers number of matches 1 person is able to umpire has been increased from 3 to 4 this is only applicable to the club that has the double duty. If in the case of an Umpire becoming incapacitated during a game the TO is to officiate until another suitable umpire is able to takeover. The TO on lower grade senior games (C Grade) does not need to be an accredited PMHHA umpire. Game should not continue with only 1 umpire as per HNSW guidelines.

2. Team Grading's – Camden Haven have named 1 more than required in their grading's. Men Rob Dwyer to be dropped, Women to be advised. The Committee accepted the grading's from all Clubs as follows:

3. Game Spreadsheet – First point of business re the Game Cards can the writing on them be legible and full name of players. Spreadsheet to be sent out to everyone so we can get an update as most of the queries are for players not on team lists. We discussed the 2 that are not registered, the Committee agreed that no points would be lost as we a happy to be playing hockey, however Keira and Brad need to be registered before they umpire and play next.

4. Discussion point (3 points from each person for things we have learned. Ideas for next year). This will form part of our end of season report.

Leane: Maybe the Association could investigate the introduction of a late entry fee, late withdrawal fee i.e. teams nominated/withdrawn after the closing date.

Kim: Suggested a closing date for individual registrations and communications re Extraordinary Circumstance e.g. COVID with parents and spectators. Ali: Being better prepared and more decisive in the beginning, also should invite the Registrar to meetings.

Tracy: Working together more collaboratively rather that shooting down everyone's suggestions/ideas take it back to the Club Membership for their input, and come up with a suitable solution rather than just saying that will not work, at the end of the days kids just want to play hockey and they do not care who they play for as long as they are with their friends.

Sarah: focus on building our Association and rather than 1 rep from each Club there could be 2 and if one cannot make the other can.

Brad: Consistency in the Senior Competition formats and more games to be played on Saturdays rather than during the week.

Heath: Agreed with everything stated.

5. Extra games for Open Women and C Men – Kim had put forward a suggestion in relation to Open Women and C Grade Men extra games required. Both Grades need to play 2 rounds for even matches, it was suggested Sunday 23/8/2020 and Sunday 6/9/2020 for these to be played. Kim to put forward the details to Robyn so that it can be added into the draw for sufficient notice to the Clubs. The extra game for Open Men gives them the same amount of matches (i.e. 10 games), not necessarily playing each team the same number of times, we felt that it is fairer for them to play 10 matches the same as Open Women and C Men after their Sunday games.

6. Exemptions for Rosina Smith and Grace Smith – these should not be assessed under the Cross Play ruling as they are no longer playing for Omni, they will continue to play only for Cruisers. TP lodged the team change as a Dispensation as it was seen not as an exemption, but a full team change for the 2 players and comments reflected the change and reason in Revolution. The Committee recommended that this needed to be approved by the CMC before the girls took the field for Round 2. No points to be lost. CMC approved the move to Cruisers.

7. 2020 Policy Addendum – CMC happy with Draft Addendum put forward by Simon.

8. Kim asked if okay to remove Sophia Hemsley from Cruisers as she will only be playing for Sistas, CMC agreed. Also there are 3 under 11 transfers yet to be finalised that will then be added to TPT Hailstones.

9. Kim also mentioned that they has been an increasing number of men in the night games who have been going behind the Dugouts to pee, can we please get a message out to the Clubs that this will not be tolerated, and to please use the toilets, if caught maybe a fine could be imposed, also maybe a sensor light could be installed to deter this action.

10. We need to ensure that spectators are aware that they need to sign in each time they enter the complex if they are not being listed on a playing card. Apparently some people are under the assumption that they sign in once for the week/weekend.

1. 2. Port City C Grade deferment (6/9/2020) – Sarah reported has not heard anything further, advised we need to know a date or something more formal by Saturday.
