PORT MACQUARIE HASTINGS HOCKEY ASSOCIATION CONDITIONS OF ENTRY TO PORT MACQUARIE HOCKEY FACILITY

General

- All persons entering Port Macquarie Hockey Facility (PMHF) are bound by the relevant constitution, policies, by-laws, playing rules, codes of conduct, etc of Port Macquarie Hastings Hockey Association (PMHHA).
- To participate in ANY activity, all persons must be appropriately registered and have the required insurances in place to participate. This includes Coaches, Managers, Umpires, Technical Officials, and all non-hockey users.
- PMHF is a licenced venue. No Alcohol is to be brought into or taken out of PMHF.
- Persons who bring valuables into the facility do so at their own risk.
- Rubbish to be placed in appropriate rubbish bins provided.
- Children must be closely supervised by an appropriate adult (18+ years). Supervising adults must abide by all conditions of entry to both PMHF and the playing surface.
- Entry and exit points to the playing fields are located at the dugouts. DO NOT JUMP FIELD FENCES.

Prohibited Items

- No BYO Alcohol
- No glass bottles, containers, or drink receptacles or other portable and breakable glass.
- No smoking, including e-cigarettes, at any location within any part of PMHF (including the carpark)

Pets

- Family pets may be brought into the facility but MUST always remain on a lead and under control.
- Pets generally are only permitted on the grassed areas of the facility.
- Owners must clean up after their pets. Persons that fail to clean up after their pets will be asked to leave the facility with their pets.
- Owners of unruly, aggressive, or pets that are fighting or causing nuisance may be asked to remove their pets from the facility.
- Pets must NOT;
 - be taken on to the playing surface.
 - be taken into any buildings, including dugouts.
 - \circ remain under the covered area of the clubhouse.

Dugouts and Playing Surface

- DUGOUTS AND PLAYING SURFACES FOR APPROVED MATCH PARTICIPANTS ONLY.
- Only appropriate covered sporting shoes to be warn in dugouts or on playing surface.
- No thongs, sprigs, cleats, stilettos, metals studs, or metal fittings permitted on playing surface or in dugouts including metal buckles on any protective equipment.

- Footwear with dirt, mud, or stones not permitted in dugouts or on turf and must be cleaned prior to entry.
- No smoking, eating, drinking (except water / sports drinks), chewing gum, or spitting.
- No entry to dugouts whilst games are in progress.
- No warming up on turf whilst games are in progress.
- Bookings and training sessions must start and finish at scheduled times.
- All injuries involving blood must be treated. Blood-stained areas must, at a minimum, be diluted with at least 5L of water.
- No blood-stained clothing is to be warn during training, games or at any other times.
- No persons other than players and umpires are to enter or be on the playing surface during any match unless invited by the match umpires.

Risk Warning

• Under Section 5M of the Civil Liabilities Act 2002: Players, spectators, officials, and all other visitors are warned that the recreational activities undertaken in these facilities involve the risk of injury.

First Aid

- The hirer / user / team is responsible for all aspects of their own first aid.
- If an ambulance needs to be called and they need to gain entry via the eastern gates, there is an Emergency Access Key located in each of the technical official dugout areas.
- AED's are located and signed around the facility for emergency use.

Refusal To Comply

- Refusal to comply with these Conditions may result in removal from or refusal to enter the facility, and / or disciplinary action under the Constitution, playing rules, by-laws, etc.
- Nothing in these conditions shall prevent police, civil or criminal actions being undertaken, either on their own, or in addition to administrative actions.

Reporting Issues and Incidents

• All issues and incidents are to be reported to PMHHA Committee
